

### **July Meeting Highlights**

The July TFTRC meeting focused on the possible merger of the City of St. Louis with St. Louis County. Chris Howard, Legislative Assistant to County Councilman Mark Harder was our featured speaker. Chris has studied this topic and offered some insights regarding how this merger might come about. Some possible paths a merger could take are (1) a "unigov" for the St. Louis region; (2) a borough system similar to one proposed by Gene McNary or (3) a re-entry of the city back into St. Louis County. The re-entry seems to be the most likely possibility.

At this point we need to become acquainted with an organization called "Better Together". As the name implies, this group clearly has an agenda for combining the city with the county. It was started in 2013 led by Mayor Francis Slay and County Executive Charlie Dooley with retired investment guru Rex Sinquefield funding it. Better Together sponsored six studies over 16 months on public finance, economic development, public health, public safety, parks & recreation and finally infrastructure and administration.

Why does Better Together push for a merger? The stated reason is to address the regional problems of crime, poor economic growth, fragmented government and corruption. Chris says that if these problems are not directly addressed, we will indeed get a merger. Crime is partly tied to poor economic opportunities, but there is a lack of will in getting tough on crime. This is the "Ferguson Effect" which makes police officers think twice about the optics of aggressively dealing with lawbreakers. Meanwhile the St. Louis area continues to lose population to other areas with more economic growth. Better Together says that its proposals will answer these problems.

Since the Missouri Constitution states that there are 114 counties and one independent city, the merger would require a state-wide referendum in order to change the constitution. But there are a number of paths that could be taken to set this up. First of all, supporters and opponents of the merger cross political lines. This is not at all a Democrat vs. Republican issue. The most likely way is through incremental changes such as combining the police force or other governmental entities. Simple re-entry is the straightest path toward the merger goal.

This leads us to the St. Louis County Boundary Commission. First, a map plan is submitted. The commission operates on five-year plans. A municipality or city submits this when it wants to merge with other areas. Next, a plan of intent is submitted. It takes 52 pages to describe the eleven items comprising the plan of intent. Written documents are submitted to the Boundary Commission which then takes nine months to decide on their recommendations. After this, it *could* be submitted to a vote of the people, but there are legislators in Jefferson City who may decide that City and County residents will have no vote. Instead, they may put this in the hands of a freeholder process in which their hand-picked panel decides this issue. If the panel approves the re-entry request by the City, there will be a state-wide referendum to change the constitution. It the referendum passes, the merger will take place within six months.

Chris gave two examples of how this would impact St. Louis County. The county budget is divided into twelve funds with transportation being one of them. The county is responsible for maintaining all arterial roads in its jurisdiction. Butler Hill Road is an example. Now think about all the arterial roads in the city and add that to the mix. It would double or triple the county transportation budget which is currently \$54 million. The county courthouse was recently renovated to the tune of \$114 million. The city courthouse is in even worse condition and would require renovations more in the neighborhood of \$150 million. County taxpayers will be bearing the brunt of this.

Young people would be more supportive of a merger simply to get 5G internet communications. Currently internet providers are reluctant to upgrade their services because the regulations vary across the 93 different municipalities. Merger supporters will use this to appeal to young voters who are not as worried about high taxes.

We have to band together to <u>actively</u> do what is needed to stop this. The people pushing this merger have been working towards this goal for years and they have the

money on their side. The first thing we need to insist upon is that no merger takes place without a vote from <u>only</u> the residents of St. Louis City and County. More information will be forthcoming regarding organized efforts to block the merger.

St. Louis businessman Fred Sauer spoke to our group briefly. He brought a supply of his booklet *Wake Up St. Louis County! Rex Sinquefield Wants You to Pay for His Empire.* Mr. Sauer has done comprehensive research into the financial affairs of both the city and county governments. His findings reveal the city's gross mismanagement of taxpayer dollars by having too many government workers on the payroll. These workers are paid inflated salaries and benefits as shown below.

Ed Ryan, Director and Secretary of Mehlville Fire Protection District spoke briefly about the plans that Better Together has for the consolidation of fire districts into an area-wide district. The plans call for a laundry list of improvements. Mehlville Fire District residents would see their real estate taxes increase by 10 to 15 cents just to fund the manpower increases alone. Then there's the increased number of firehouses, fire trucks and other equipment that will be paid for by you.

#### **Good Book to Read**

Sharyl Attkisson's first best-selling book *Stonewalled* detailed the ways in which the media and the news narrative are controlled and manipulated by corporations and special interests. Her most recent book is The Smear: How Shady Political Operatives and Fake News Control What You See, What You Think and How You Vote. The title really says it all. Attkisson goes into how political and corporate operatives have colluded with a compliant mainstream media in order to influence public opinion and take out enemies. She outlines the various techniques used in order to smear opponents and names the big players in the smear industry. The biggest one is David Brock who heads Media Matters for America and an entire conglomerate of political action committees focused on advancing liberal policies and candidates. Attkisson describes transactional journalism: the practice of government operatives writing "news" stories and then delivering those stories to compliant reporters in order to get their spin on the news cycle. The 2016 election capped thirty years of smear tactics and resulted in Donald Trump's election in spite of all the smears targeting him from both the political right and left. If you weren't cynical before reading this book, you certainly will be afterwards. Well-informed citizens need to read this book just to develop a critical attitude towards the news they are taking in everyday. Find this best-seller at the St. Louis County Library.

#### **Missouri Initiative Petition Process**

You feel strongly about trashing or keeping our new right-to-work law. You are passionate about whether or not we should legalize medical marijuana. Secretary of State Jay Ashcroft has approved 133 initiative petitions for circulation. Petitions proposing statutory changes must be signed by 5% of the legal voters in any 6 of the 8 Congressional Districts. Petitions proposing constitutional changes must be signed by 8% of the legal voters in any 6 of the 8 Congressional Districts. The key deadline is May 6, 2018. The petition gatherers must deliver the valid signatures to the Secretary of State by that day to have a chance to be on the November 2018 ballot. ## What Would a Regional St. Louis Fire District Cost?



In our July meeting Mehlville Fire Director Ed Ryan touched upon some of the increased costs that would be incurred if the Better Together plans were implemented for a regional St. Louis fire district. Here's some of the numbers taken from their study. Watch out for the word "investment"; it means taxes.

In addition, current firefighters across the metropolitan region would be converted to the new pay structure. No firefighters would see a reduction in their pay or benefits. The estimated cost of pay parity for current employees is \$23 Million for the first year of integration. This assumes pay would be frozen for firefighters making more than the estimated new salary structure.

While all these improvements made to a regional fire district would be spread over several years, the costs would still be staggering when you consider that this would only be one part of the regional budget. This doesn't touch roads, courts or police. There is also an assumption that there will be cost savings due to economy of scale, but we've seen how that works for the federal government. Throw in some more city mismanagement and corruption and the cost savings disappear as well. No doubt, fire protection across the area would improve if all these things were implemented, but this doesn't address how it will be paid for or who governs this. Residents in the Mehlville Fire Protection District would be paying a lot more with marginal improvements at best.
